National Human Rights Commission (NHRC) has reiterated its commitment to ensure that any person or group who indulges in ostracization of any citizen despite warning by the Commission is punished in accordance with the law.

A member of the Special Investigation Panel on

Sexual and Gender Based Violence (SGBV) Mr. Abdulrahman Yakubu who disclosed this recently while chairing the Panel in Ebonyi state on behalf of the Executive Secretary, Tony Ojukwu Esq. assured Nigerians that it will no longer be business as usual for the perpetrators of highly discriminatory acts.

According to the Human Rights Defender, the idea of ostracising some members of the community upon some flimsy excuses such as defaulting in payment of community levies runs contrary to the Constitution of Nigeria as well as relevant regional and international Conventions to which Nigeria is a signatory.

Continuing, he stated that there are better and lawful procedures for addressing issues involving deviant members of the society which ostracization cannot be an option.

Yakubu who is also a member of the Independent Investigative Panel on allegations of human rights violations by the defunct SARS also decried the torture, inhuman and degrading treatment meted out to some women in Amasiri Community of Afikpo North local government Area of Ebonyi state by the Chief, members of his cabinet and the town crier.

## NHRC RESCUES CAGED WOMAN IN KATSINA. ENSURES SHE GETS MEDICAL ATTENTION

he Katsina office of the NHRC has Laritu's imprisonment in Gyaza on the ground of alleged mental health issues. Barrister Adamu said it took the intervention of the Commission and other stakeholders to rescue the victim from the inhuman and degrading treatment meted upon her by her family members. He said investigation revealed that the woman who was kept in a filthy environment unsuitable for human habitation had for a long time been denied her rights to dignity of a human person; a situation he lamented may have contributed to her state of mental instability.

The Commission's State coordinator who ordered the immediate release of Laritu from the deplorable condition she was subjected to also tasked the family to urgently take her to the hospital for thorough medical examination and care, stressing that the Commission will continue to monitor the condition of the victim to ensure that she gets the right kind of treatment she deserves.

Adamu used this medium to educate the family of the victim on human rights norms reiterating that every person deserves to live in dignity and be free from all forms of cruel, inhuman and degrading treatment, asserting that the 1999 Constitution of Federal Republic of Nigeria as amended provides for the right to life and dignity, therefore any action that infringe on this fundamental right or any other human right is highly unacceptable and must be discouraged in all ramifications.

### NHRC COMMENCES SECOND PHASE HEARING ON SGBV IN ENUGU. RECEIVES 28 COMPLAINTS

special investigation panel on Sexual and Gender Based Violence, (SGBV) constituted by the National Human Rights Commission has commenced hearing in Enugu, South East Nigeria.

The sitting is organised by the NHRC in partnership with EU UN Spotlight Initiative, and with the support of other stakeholders like People of Japan, etc.

The Executive Secretary of the National Human Rights Commission, Tony Ojukwu Esq in an address, noted that the panel received one hundred and thirteen complaints across the six geo-political zones, with south east accounting for the highest number of thirty-five, representing 30% of the total complaints received.

"This panel was constituted as a result of the complaint received on Friday the 26th of April 2019, where armed security personnel led by the Abuja Environmental Protection Board, (AEPB) under the auspices of the FCT Joint Task Force raided night clubs and the streets of Abuja. They claimed that the raids were intended to arrest prostitutes in which about 71 women were arrested and held in different police stations in Abuja".

### ALLEGED THREAT TO LIFE: FORMER ZAMFARA GOVERNOR APPEARS BEFORE IIP-SARS READY TO SETTLE OUTSIDE PANEL

ormer Zamfara state Governor, Senator Ahmad Yerima on Wednesday appeared before the Independent Investigative Panel on alleged human rights violation by the defunct Special Anti-Robbery Squad (SARS) and other units of the Nigerian Police following his summon over alleged complicity in threatening the life of a businessman, Alhaji Musa Wapa.

Yerima was summoned by the panel to answer to allegations that he mobilised some Police Officers to arrest, torture and detain the Katsina State born business man over a claim of N23million.

In their response, the two parties agreed to resolve the issue amicably. The panel further directed that counsel to the panel should monitor the settlement as amicus curiae to ensure amicable settlement between the two parties. The matter was adjourned to 5th of March, 2021 for the report of the settlement to be submitted before the panel.

"In these raids, nine or very few men were arrested. Victims of the raid made serious allegations of rape, sexual harassment, and cruel, inhuman and degrading treatments".

Ojukwu said that the incident raised an outcry on the SGBV menace in homes, work places, church places, and other places of worship. "The case of little Ochanya in Benue state can also not be overemphasized" Oiukwu noted.

Details of the terms of reference of the panel, include but not limited to review extant laws and regulations applicable to joint task forces in all the states and FCT in particular, especially the Abuja Environmental Protection Board (AEPB) and whether such laws and regulations are compliant with Chapter 4 of the 1999 Constitution and other international human rights conventions and protocols applicable to Nigeria.

Others are to identify individuals directly responsible for any violations and abuses and make recommendations for further actions including but not limited to prosecutions, disciplinary proceedings and damages amongst others.

The complainant has earlier testified how Yerima used the IGP- Intelligence Response Team to deny him the payment of N25 million for three trailers of corn he supplied to his farm, (Rufai Poultry Nigeria Ltd). During his cross examination before the panel, the complainant had informed the panel that Yerima owed him the sum of N25m even as he admitted that he (Wapa) also owed the Senator N23m.

He said that his First Bank account has been frozen as a result of his issue with Senator Yerima and the Police. Asked what he wants the panel to do for him, he pleaded with the panel for N100million compensation, for the alleged violations and tarnishing of his image, saying the Police made him to appear as a terrorist.

In his cross-examination, counsel to the Nigerian Police, Mr. James Idachaba (DCP), told the panel that Wapa's arrest was sequel to a court order, which Wapa said he was not aware of. o



commended the complainants and the public for the courage to lodge and follow up their complaints and submit memoranda to this Panel despite some reported cases of intimidation.

"I want to reiterate the assurance of this Panel and the Commission's commitment to the principles of fair hearing in discharging its functions". Ojukwu said.

The Commission also thanked the Governor of Enugu state, Ifeanyi Ugwuanyi for his support in providing a convenient climate for Human Rights works in the state through zero tolerance to Sexual and Gender Based Violence (SGBV).

### IIP-SARS DNA TEST SHOWS WOMAN NOT THE MOTHER OF HER "SON"

result before the panel said the integrity of the test is 99% he told the panel how he advised the police to declare that there is a match else the circle will not end as a fifth claimant to the child has surfaced

It would be recall that Esther Tanko petitioned the panel sometime in November 2020 over allege abduction and enforce disappearance of her son Elijah Tanko by one Chioma and an unidentified man on 9 October 2019.

Esther narrated to the panel how her attention was drawn to images circulating on social media about missing children and she said her son happens to be among the missing children, and was declared to be in the custody of the Anti-Robbery Squad. (SARS) she noted.

The complainant said she went to SARS to identify her son unexpectedly there were other parents laying claim to the child as theirs despite the fact that the child identified and called out to her on seeina her.

With this development, the complainant said she was then asked to go for a DNA test to determine the maternity of the said child, but due to lack of funds to conduct the medical test Abba Kyari paid for the medical bills.

Esther brought before the panel as evidence a birth certificate, polio vaccination card and pictures of her missing child.

The case has been adjourned to 7 April 2021 for submission of written address.

### HRC TASKS EBONYI COMMUNITIES AGAINST OSTRACIZATION IIP-SARS DNA TEST SHOWS WOMAN NOT THE MOTHER OF HER "SON"

r Kelvin Nwabueze a consultant pathologist forensic centre in Lagos for analysis. and the head of the anatomic pathology and forensic medicine at Asokoro district hospital Abuja, has appeared before the justice Suleiman Galadima led IIP-SARS panel regarding the issue of alleged abduction and enforced disappearance of a child Elijah Tanko brought before the panel by an indigent woman Esther

The medical practitioner informed the panel that in July 2020 he was contacted by DCP Abba Kyari of the Inspector General of police intelligence Response Team to run a DNA test on a child recovered from alleged child traffickers, and three different women claiming to be the mother of the

Continuing the doctor said samples of the child in question and the following women; Esther Tanko, Ifeyinwa Vera and Rosemary Chidiebere respectively were taken at the Asokoro General Hospital, and were sealed in the presence of the women's witnesses and the IPO in charge of the case for onward transmission via FEDEX to a Meanwhile Dr Nwabueze while interpreting the

However, while the result was being awaited according to the Dr a fourth claimant to the child surfaced and reported to the IRT unit. He said at that time the IRT contacted him but he told them that the results were already out and the maternity investigation proves Rosemary Chidiebere was the biological mother of the unknown child, he stated.

But the police insisted in the interest of fairness the fourth woman Jamui Muniat be investigated also so her samples were taken and that of the unknown child and sent to the forensic centre in Lagos again, but unfortunately, he said the EndSARS protest broke out the centre was vandalize, he added.

Dr Nwabueze said due to the importance attached to the investigation, he contacted a world leading centre on DNA called DDC in Ohio United State and they referred him to their Nigerian agent Arrive and Alive centre in Lagos where the fourth test was later conducted.

## OJUKWU. STAKEHOLDERS HARP ON BENEFITS OF HUMAN RIGHTS EDUCATION IN SCHOOLS

xecutive Secretary National Human Rights Commission (NHRC), Tony Ojukwu Esq. has called for a stronger commitment of stakeholders in entrenching a culture of respect for human rights and dignity in schools across the Country.

Ojukwu stated this in Abuja during a workshop on the Implementation of Human Rights Education in the School System in Nigeria.

The NHRC Boss said the workshop which was organized by the Commission with support from the Danish Institute for Human Rights has created another

According to him, Nigeria's adoption of the UN Declaration on Human Rights Education and Training 2011 and WPHRE 2004 respectively speak volumes about platform to highlight the benefits of the resolve to build a formidable and viable country that is strong to ensure quality education, knowledge and skills needed to promote lifelong learning opportunities and sustainable development.

## SARS OPERATIVES HANGED ME FROM THE CEILING. TORTURED ME AND BROKE MY LEG

Panel on allegations of human rights violations by the defunct Special Anti-Robbery Squad (SARS) and other units of the Nigerian Police on Friday listened to how SARS operatives severely tortured one John Ogbu at their office, 'Abattoir', and broke his leg.

John Ogbu, a dealer in new and second hand electronic and home appliances in Gwagwalada narrated to the panel that on the 24th April 2018, at about 3pm, a man, who he later identified as Insp Edwin Kendiry came to his shop with a stranger who claims that he sold stolen electronics to Ogbu.

In his testimony before the panel, Ogbu said immediately the stranger pointed him out, Insp Edwin carried nine television sets from his shop without explanation and thereafter he

Tetengi SAN, who stood in for the Chairman, Ogbu said the next day he was taken to the torture room where his arms were twisted to the back and chained to his legs which were bent behind from the knee, he was then hanged onto the ceiling and

### DEATH IN CUSTODY: VICTIM DID NOT DIE OF SUBSTANCE ABUSE AS ALLEGED BY POLICE

he Chief Consultant Pathologist of University of Abuja Teaching Hospital, Gwagwalada (UATH) on Wednesday appeared before the Independent Investigative Panel on human rights violations by the disbanded Special Anti-Robbery Squad (SARS) and other police units following summons to clear the air on the cause of death of late Ifeoma Abugu whom the police alleged died in custody following substance abuse.

Dr Abimiku in his analysis of the autopsy result he conducted on the late Ifeoma Abugu before the Justice Suleiman Galadima(rtd) led panel, stated that from his preliminary autopsy examination he noticed that her fingernails, lips and tongue were bluish, indicating that she had respiratory problem before she died.

Explaining further, the pathologist said there were bruises on her knees. According to him, a cursory look at her organs revealed that there was accumulation of fluid in her lungs causing pulmonary congestion. His examination of her kidney also revealed noncancerous cyst, multiple fibroid in her uterus and virginal swab shows dead sperms deposited in her body.

Continuing, he said in his thorough investigation of the cause of death as alleged by the police, he did a toxicology test to ascertain the allegation that she died from drug ingestion. He said he did this by way of testing her body fluids for all the eleven drugs commonly abused, like Rohypnol, diazepam, barbiturate, marijuana, narcotic, cannabis, tranquilizers, amphetamines etc and all results came back negative.

To rule out all doubts, Dr Abimiku informed the panel that he further tested the late Ifeoma specifically for cocaine and still the result came out negative.

At this point Dr Abimiku disclosed to the 11man investigative panel that the cause of death of Ifeoma Abugu was Anoxia, a medical condition caused by a decreased or lack of oxygen supply to the lungs. "And this can come about as a result of strangulation, choking or suffocation "he added.

Under cross examination, the counsel to the respondents James Idachaba tried to discredit the report by alleging that the autopsy result was in contention because his respondents sought for second opinion on the result therefore he alleged the autopsy lacked integrity.

The doctor responded by saying "Autopsy result does not favour anybody, it is meant to establish the cause death".

Although the autopsy was done at the instance of the police, the panel members asked if the period of death and the time autopsy was conducted could change anything, the pathologist answered in the negative saying longer period can only make dissection difficult. But he was quick to add that the virginal swap result if done early could have made a DNA of the sperm found in her possible; however that cannot be possible because sperm can only live for 72 hours in a woman's body.

On the circumstances that led to the autopsy which was conducted by Dr Abimiku, he informed the panel that, the IPO alleged that Ifeoma Abugu's fiancé was a suspected drug dealer and when they went to arrest him on the 10th September, 2020 they met Ifeoma at home, who he also claims was into sale and consumption of drugs. She was then arrested and she later died in police custody on the 11th of September, 2020 of alleged drug overdose. In a bid to establish her cause of death she was taken to the hospital on the 25th of September 2020 for autopsy. In his response the chairman of the panel ordered the immediate release of the corpse to the family for proper burial rites, and the case was adjourned to 24th March 2021 for the police to open their defence.

It will be recalled that the case was part heard in February 2021 when Afam Ugwunwa, the fiancé, testified before the panel that she died in custody of the police.

Afam also said that the police alleged Ifeoma died of drug abuse, while the autopsy states that she died of anoxia.

It was as a result of the discrepancies between the police and the complainant that informed the decision of the panel to summon the Chief Consultant Pathologist who has now given a medical account of the circumstances of her death.
